Adjudicator Training Programmes

S A U D C Siriwardena attended the TCDPAP (Technical Corporation Development Programme in Asia Pacific) international conference held in Hanoi Vietnam from 14th to 17th April 2010. Eng. J Karunaratne Presented a paper on ‘Meeting the Challenges of Consultancy Business by Innovative Approaches’ Further Honorary Secretary attended the TCDPAP council meeting held on 15th April 2010 as the Country Representative. He was successful in obtaining the Council’s consent to hold the TCDPAP international conference for 2012 in Sri Lanka. TCDPAP Conference 2011 will be held in Malaysia.

FIDIC NEWS

Registrations are open for the FIDIC conference in New Delhi, taking place from 19-22 September. FIDIC looks forward to strong delegations from all member associations.

FIDIC training courses took place in Jordan, Serbia, Botswana, India, Latvia, Qatar, Belgium and Abu Dhabi. Please check the FIDIC website for upcoming events. To meet the increased demand for FIDIC training, potential trainers are being identified and put through suitable training in order to become accredited as FIDIC trainers.

FIDIC Integrity Management Committee met in Geneva, in order to revise FIDIC’s Business Integrity Management System (BIMS). This is being undertaken, to develop a new strategy for integrity management for the consulting engineering industry.

The FIDIC President, MD and EC member attended the successful GAMA conference held in Mombasa and spoke about the state of the global industry, and the need for engineers to become more involved in political debate and policy development. A post conference workshop highlighted new opportunities for public/private investment in African infrastructure. A number of new African associations are being approached for

membership of FIDIC and GAMA.

Intensive discussions took place with Indian colleagues in Delhi, in order to finalise arrangements for the action packed FIDIC conference in September 2010. A range of national and international speakers will explore Innovation as the “Way Forward”.

FIDIC/EFCA Task Force met and reached broad agreement on a new proposal for cooperation aimed at streamlining activities for the industry in Europe, and enabling FIDIC greater representation in Europe. The proposal will be presented to the General Assembly later in the year for ratification.

Further discussions took place with colleagues in Tunisia to plan the FIDIC 2011 conference to be held in Tunis from 18-21 September 2011. A strong African flavour is envisaged, with GAMA to join forces with FIDIC for this special event. Thinking Global as well as Local with regard to resources is a vital issue for the industry.

FIDIC 2013 Organising Committee met in Madrid to develop a strategy for the centenary event of FIDIC being held in Barcelona in September 2013. A number of FIDIC Member Associations are to be contacted shortly to assist in the planning of this significant event. Henning Therkelson from Denmark was appointed to chair the important Capacity Building Committee, after the recent retirement of Bayo Adeola from Nigeria. The committee is tasked with reviewing its Terms of Reference in order to concentrate on FIDIC’s training tools and guidelines, as well as new strategies for the future needs of the industry.

The status of several member associations is being reviewed as a result of changes to internal structures. Meantime, a FIDIC subscription task force is assessing a number of models, with the aim of presenting to FIDIC members a proposal for a more equitable distribution of subscription fees. A report is expected at the FIDIC conference in September.

PLANET UNDER STRESS –MORE FOOD FOR THOUGHT

The human being is an animal that has moved out of ecological balance with the environment. Humankind is a wasteful killer and a despoiler of other life on the planet. This normal and apparently acceptable behavior has been licensed by a belief that our use of the Earth’s Resources is God-given, and encouraged by an economic system that sympathises short term profit as a benefit. We are only slowly learning to put a real cost on the resources we consume, and the wastes we produce. Humankind is now dominant in effecting perhaps irreversible change on the Earth’s surface, and may be we do not know enough to decide how to run this planet. We are forcing our will upon it, using ever depleting resources and increasing waste discharge., while at the same time claiming that we must aim for “sustainable development, which has been defined as development that meets the needs of the present without compromising the ability of future generations to meet their own needs. This forces us to consider if the present level of resources and waste production can be sustained, to question the concept of growth economics, and to admit that it would be impossible to extend current Western Standards of living to the world as a whole.

It seems that there are two major forces at work preventing us from attaining true Global Sustainability.:

- (1) Population growth seems to be the single most important factor in increasing environment stress, including depletion of materials and energy resources and a runaway increase in solid, liquid, gaseous, and heat waste. We are currently adding one billion to the population of the world every eleven years. . Most of the resources and most of the waste produced are due to the activities of a relatively small proportion of the total population. In certain areas of the world people are reproducing much more rapidly than in the West, but a

Western baby will drive a car when it grows up, and will use resources and produce waste a hundred to five hundred times more than many of the babies born in the Third World. Recent studies suggest that with current dietary patterns we have reached or even exceeded the carrying capacity of the globe in population. .

- (2) Our use of the Fossil Fuels continues to grow. If the relative decline in the use of petroleum products as fuel continues, it will be more than offset by an increase in coal burning, which will further increase the greenhouse gases and particulates in the atmosphere. That in turn will increase the warming effect, which has already started. Bearing in mind the inevitable change in climate and rise in sea level that results from warming, how much more can we accept?

Scientists can point out and measure many of the changes taking place in our immediate environment and our own lives. But it will take very much more than science to change our current system, and persuade us to learn to live in balance with Earth's ecosystem. All people on Earth are in this together, and so must find a joint solution. It is too late to build walls around, or put roofs over regions of the world. The problems are exclusively global, and the solutions must be also. We are now faced with a task that is more difficult than anything we have ever contemplated: to decide how we may continue to live on this small planet. Any departure from ecological balance that destroys most of the remaining life on earth – and the big killing is under way – will mean that we are doomed to a similar fate. In other words, it is imperative that we learn to live in balance with all of earth's complexities. Humankind has never before been faced so urgently with such a challenge - but face it we must - or life on this planet, for human beings may become unsupportable.
